- 5. <u>126<sup>th</sup> National Convention, August 9 August 13, 2025</u>, Columbus, OH. Information is posted on the VFW National & VFWOH.org website.
- 6. As the upcoming Memorial Day approaches it is appropriate that we direct as many VFW resources as possible to support our troops and their families. In the ongoing effort to provide as much assistance as possible to those serving in the military, we recommend that proceeds or portions from this year's annual poppy distribution be designated for the purpose of providing VFW support to our military, Via the VFW Department of Ohio Military Assistance Program (MAP). In keeping with the intent of Section 704 (A) (C) of the Manual of Procedure "Relief Fund", this year's poppy campaign can play a direct role in demonstrating to those who are charged with protecting and defending our way of life that we appreciate and value their sacrifice.
- 7. The National Headquarters Life Membership Board of Trustees have approved the following 2024-2025 Life Member Payout. The National Council of Administration concurred with the payout amounts at its March 3, 2024 meeting:
  - Plan ABC A total payout of \$10.50 for each life member (\$3.50 to each Post, Department and National).
  - Plan D A total payout of \$11.70 for each life member (\$3.90 to each Post, Department and National).
  - Plan E A total payout of \$23.10 for each life member (\$7.70 to each Post, Department and National).

Note: At-Large Members are corresponding Plan pay out amount divided by two. For example, Plan ABC At-Large Payout is \$5.25.

As indicated in the By-Laws, payment will be made in September 2025 for all Life Members, recorded as of August 31, 2025. In addition, payment will be made in January 2026 for all Life Members processed during the period September 1 through December 31, 2025.
